



INVITATION OF BIDS FOR CONDUCTING CONCURRENT AUDIT OF THE BANK FOR THE YEAR 2026-27

Applications are invited from eligible Chartered Accountant (CA) Firms for conducting Concurrent Audit of the District Cooperative Central Bank Limited (DCCB) for the Financial Year 2026-27.

Schedule of Events:

Opening date of application: 14.03.2026

Last date of application: 23.03.2026

I. Job Profile:

To conduct Concurrent Audit of DCCB Eluru, Central Office and its 34 Branches (Annexure I) for the FY 2026-27.

II. Eligibility Criteria:

- The Audit Firm shall have been enrolled/ registered with Institute of Chartered Accountants of India (ICAI).
- Audit firms having experience in Bank audit for 03 years and more.
- The audit firms name shall appear in the Diploma in Information System Audit (DISA) qualified list of CAs provided by ICAI.
- The partners/LLP/firm/designated partners of the firm/ or the proprietor should not have any disciplinary matters pending with IBA/ ICAI/ RBI/ NABARD/ National Financial Reporting Authority(NFRA) and they should not have suffered any disqualification.
- If the name appearing in the list of third party entities prepared by IBA, or list of entities blacklisted by professional bodies such as ICAI or blacklist of other banks, then no empanelment would be considered.
- Audit to be conducted as per the extant guidelines of NABARD/RBI.
- **The Audit Firm who already conducted the Concurrent Audit for the past 3 years continuously to the DCCB Eluru are not eligible to apply.**

III. Procedure for Empanelment:

The selection of Chartered Accountant firms as Concurrent Auditors of the Bank is completely based on the soundness and experience of the CAs and Professional Staff available in the firms. The Bank reserves the right to finalize the CA firms and appoint as Concurrent Auditors of the Bank for the FY 2026-27.

IV. Application Guidelines:

- Chartered Accountant firms can apply from 14.03.2026 to 23.03.2026 in the application proforma prescribed by the Bank.
- Incomplete applications and/or applications without aforesaid documents will be rejected without assigning any reason thereof.

- Any resultant dispute arising out of this notification shall be subject to the sole jurisdiction of the courts situated in Eluru.
- The eligible interested LLPs/Firms/Proprietary concerns shall apply offline or online through Bank website <https://elurudccb.bank.in> within the stipulated time.

V. Disclaimer:

In case it is detected at any stage that the firm does not fulfill the eligibility norms and it has furnished any incorrect/false information or suppressed any material fact(s), the application will stand cancelled. If any of these shortcomings is/ are detected even after appointment, their services are liable to be terminated. Decision of DCCB Eluru in all matters regarding eligibility and selection would be final and binding on all applications/firms. No further representations or correspondence will be entertained by DCCB Eluru in this regard.
